We process personal data on the basis of the following legal grounds under the General Data Protection Regulation (GDPR):

Retention Periods

Atlas Village Brielle BV does not retain personal data for longer than necessary for the purposes for which it was collected, unless we are legally required to retain the data for a longer period.

Administrative data relevant to tax legislation is retained in accordance with the statutory retention period of 7 years.

Sharing Personal Data with Third Parties

Atlas Village Brielle BV only provides personal data to third parties if this is necessary for the provision of our services or to comply with legal obligations.

For the management of reservations and hotel administration, we use external systems, including:

- Protel (Property Management System)
- SmarHOTEL (channel manager and reservation integrations)

These parties process personal data on behalf of Atlas Village Brielle BV. Data processing agreements have been concluded with these parties to ensure that your personal data is handled carefully and protected in accordance with the General Data Protection Regulation (GDPR).

In addition, personal data may be processed by third parties for:

- Payment processing
- Website hosting
- IT support
- Reservation platforms such as Booking.com and Expedia

We never sell your personal data to third parties.

Cookies or Similar Technologies

Our website uses functional and analytical cookies to ensure that the website functions properly and to analyse how the website is used.

If we use marketing cookies or tracking cookies, we will ask for your consent in advance.

Security of Personal Data

Atlas Village Brielle BV takes appropriate technical and organisational measures to protect your personal data against loss, misuse or unauthorised access.

Our systems and software providers comply with current security standards. Access to personal data is restricted to employees who require it in order to perform their duties.
